

Terms and Conditions Governing the DBS Live Fresh Card x Lazada Payday Sale Promotion ("Promotion")

Promotion Period

1. The Promotion is valid on every 24th to 27th of the month from 24 August 2024 to 27 December 2024 ("**Promotion Period**").

Eligibility

- 2. To qualify for the Promotion, the customer ("Eligible Cardmember") must fulfil the following conditions:
 - a. Collect the vouchers ("Voucher") on Lazada's mobile application (iOS and Android) ("Lazada App") during the Promotion Period; and
 - b. Make the respective minimum spend on Lazada App during the Promotion Period with his/her DBS Live Fresh Card or DBS Live Fresh Student Card ("Eligible Card").
- 3. The Promotion contains two (2) tiers of voucher, and each tier is subjected to limited redemptions each month during the Promotion Period, on a first-come, first-served basis:

Tier	Voucher Tier	Number of redemptions per month
1	S\$5 off with a minimum spending of S\$60	480
2	S\$15 off with a minimum spending of S\$150	106

- 4. Vouchers are valid for collection and redemption on the Lazada App from 8:00pm on the 24th to 11:59pm on the 27th of each month during the Promotion Period. Each cardmember is entitled to redeem only one (1) voucher each month.
- 5. Vouchers collected will be automatically applied only at the checkout payment page when an Eligible Card is used.
- 6. Vouchers are only valid for Lazada orders (excluding RedMart). Vouchers are to be used for a one-time purchase only and cannot be used in conjunction with other bank promotions, offers, vouchers, rebates or privileges except for free shipping, sellers' vouchers and Lazada collectible vouchers.
- 7. Vouchers are not applicable on delivery charges or shipping charges, over-the-phone purchases, and the following categories: digital goods; jewellery/gold; toddler formula (0-12 months); and over the counter (OTC) medicine. Vouchers may be used for selected digital goods at Lazada's sole discretion at any time.
- 8. Lazada reserves the right to cancel or modify any order, or revoke the use of Vouchers without prior notice for any reason, including the following circumstances: suspicious or fraudulent purchasing activity or Voucher use; Voucher abuse (including the use of multiple accounts or multiple checkouts associated with the same customer or group of customers); or Voucher used in bad faith (including resold Vouchers or use of Vouchers by customers purchasing products for resale).
