

## Terms & Conditions of myHome Protect II Insurance Policy Promotion ("Promotion")

- 1. The Promotion is jointly organised by DBS Bank Ltd ("**DBS**") and Chubb Insurance Singapore Limited ("**Chubb**") (collectively, the "**Organisers**"). myHome Protect II insurance policy is underwritten by Chubb and distributed by DBS.
- 2. To be eligible for the Promotion:
  - a. you must purchase a new myHome Protect II policy ("Policy") via DBS/POSB website, at any of the DBS/POSB branches or via a DBS telesales representative from 1 July 2024 to 30 September 2024 ("Promotion Period");
  - b. your application and insurance premium payment must reach and be accepted by Chubb during the Promotion Period;
  - c. your Policy must be active for 4 months from the Policy Commencement Date; and
  - d. you must not have cancelled any existing myHome Protect or myHome Protect II Policy between 1 July 2024 and 30 September 2024.
- 3. Each Policy accepted during the Promotion Period entitles you to receive a premium discount ("**Discount**") and vouchers ("**Vouchers**") on the Policy (excluding optional add-ons) as set out in the table below:

- 4. The Discount on the Policy will continue to apply to each renewal of the Policy so long as you keep the Policy active by paying the recurring premiums.
- 5. The Discount and Vouchers are non-exchangeable for cash and non-transferrable.

A redemption email/ SMS for the Vouchers will be sent by Chubb's appointed vendor (with sender email address <a href="mailto:chubb-rewards@reward360.sg">chubb-rewards@reward360.sg</a>) to the email address/ mobile number indicated on the application form within 5 months from the Policy commencement date.

- 9. The Organisers reserve the right to replace the Vouchers with items(s) of similar value without prior notice.
- 10. The Promotion is only applicable with myHome Protect II birthday deals and not applicable with other promotions, vouchers, rebates or privileges applicable to the Policy.
- 11. The Organisers may change these terms or suspend / terminate the Promotion without giving notice.
- 12. The Organisers will have the final decision on all matters regarding the Promotion.
