

Terms and Conditions Governing DBS/POSB Home Loan Bonus Promo ("Promotion")

- 1. The promotion period is from 01 July 2024 to 30 September 2024.
- 2. Promotion is only valid for <u>direct online applications</u> without third-party referrals.
- 3. Promotion is only valid for home loan granted by DBS/POSB to finance the purchase of a completed residential property in Singapore or to refinance an existing home loan obtained from another financial institution or HDB ("Home Loan"). Subjected to a minimum loan amount of S\$300,000.
