

## GSS Mobile Spin & Win (“GSS Promotion”) Terms and Conditions

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

1. DBS/POSB Credit or Debit Cardmembers (“**Cardmembers**”, each a “**Cardmember**”) will get to receive a guaranteed prize (each a “**Gift**” and collectively, the “**Gifts**”) from 21 May – 26 June 2015 (both dates inclusive) (“**Eligible Period**”), subject to a minimum spend of \$150 (“**Total Account Spend**”) charged to the DBS/POSB Credit or Debit Card (“**Card**”) during the Eligible Period.

Redemption detail for item **i)** stated above will be in the form of cash rebate, credited into the qualified Cardmember’s Credit/Debit Card account that was used for registration by 31 August 2015. Cash rebate given will be the same as the amount entered in the DBS Lifestyle App registration form, capped at S\$500 per transaction.

Redemption details for items **ii), to v)** stated above will be credited into the Cardmember’s AirAsia BIG Shot account by 31 August 2015. Redemption detail for item **x)** stated above will be via GrabTaxi's GrabPay. Cardmembers will be required to download the GrabTaxi app and set up their account (for new users) and key in their DBS/POSB Credit or Debit card number into the 'Payment' tab in the main menu page. To enjoy this rebate, Cardmembers must then choose the "CREDIT CARD" option when confirming cab booking in GrabTaxi app. Cash rebate will be credited to Cardmember's registered card account by 31 August 2015.

Redemption details for item **xi) and xii)** stated above are at:

- Any Watsons or Pizza Hut outlets islandwide

3. To qualify for the Gift redemption, Cardmembers will have to spend a minimum amount of S\$150 in a single receipt and proceed to DBS Lifestyle App's GSS Spin & Redeem to redeem the Gift.
